The Counselling Foundation of Canada is governed by a board of Directors. Donald Lawson, son of the founder is Chairman of the Board. The foundation is administered by an Executive Director.

Approximately 25 grants totalling \$2.7 million approved annually.

200,000

This two-year project will see a collaboration of funders and interested stakeholders launch a Changemakers Competition to uncover promising practices and innovation in education in Aboriginal (First Nation, Inuit & Métis) communities across Canada.

This two-year grant will support the development and production of Test Books and Resource Guides that meet the requirements of the Aboriginal Youth Entrepreneurship Program. These books are being written by Aboriginal teachers for Aboriginals leaders.

81,583

This two-year grant will support the Mentoring Internationally Trained Counsellors project. This model offers professional mentoring and supervised work experience to internationally trained psychologists and counsellors, while also mobilizing their skills and experience to meet critical mental health needs in newcomer communities.

Ndinawemaaganag Endaawaad Winnipeg, Manitoba

80,000

This grant renewal for three years will support the salary of a full-time counsellor in the Child and Youth Care Worker Certificate Program. The participants of the program are generally former sex-trade workers who face many barriers to being successful in completing their certificate program.

The Ndinawemaaganag Endaawaad is a response to the well-documented need for a culturally appropriate resource for the growing numbers of Winnipeg's Aboriginal children and youth living on the streets.

This one time grant will allow the organization to hire a research assistant to explore and catalogue community-based education internships and student placements for students in the Faculty of Art.

Prairie South School Division No. 210 Moose Jaw, Saskatchewan

50,000

This is a grant for two years of funding to support the Extended Transitions Program. This program tracks and follows high-school students and identifies those at risk of not completing their education, and those who may fall between the cracks after graduating, to ensure they continue with their education, achieve employment and/or become enrolled in a career-related employment program.

The Prairie South School Division was created in January 2006 as a result of the amalgamation of seven legacy school divisions. The division encompasses much of south-central Saskatchewan, including Moose Jaw and Assiniboia.

249,661

This three-year grant is to fund the Peer Mentorship Program. This program recruits third and fourth-year students to mentor first-year students. The peer mentors, many of whom are psychology students, are provided with extensive training and support. This helps relieve the pressure for demand on counselling resources and on services in a small rural university town.

St. Francis Xavier University offers what so many of Canada's top students are seeking: a high quality education focused principally on undergraduate courses in a vibrant residential setting. Université Laval Québec, Québec \$ 50,000

This grant renewal for two years will continue to support the Mentorship Program in developing a practical pedagogical tool to help university students enter the job market.

Université Laval traces its origins back to 1663, when Monseigneur François de Laval, the first bishop of New France, founded the Séminaire de Québec with the authorization of the King of France, Louis XIV. A Royal Charter creating Université Laval was granted to the Séminaire de Québec by Queen Victoria in 1852. A few years later, in 1878, Université Laval opened a second campus in Montréal to offer higher education teaching in that city. Université Laval's "Montreal branch" became Université de Montréal in 1920. Université Laval has been a pioneer in program assessment and strategic planning, and remains at the vanguard of the internationalization of teaching and research.

FUNDING CRITERIA AND GUIDELINES

The goals of the Foundation are:

- To promote effective delivery of career counselling through reputable and credible organizations (educational, religious and community) to individuals involved in a process of career development;
- To encourage and support information and evaluation centres for career counselling;
- To work towards the professionalization of counselling and promote public education which clarifies the role and qualifications of counsellors; and
- To encourage and support programs which contribute to healthy child development especially for those groups of parents and children known to be at greatest risk.

Projects which partner community resources are preferred. All grants are time limited and subjects to an annual review.

Application for grants which fall within the guidelines will be considered by the Board of Directors of the Foundation. Approval or rejection of a grant will be at the discretion of the Board. The Board generally meets to consider application 3 to 4 times per year. In order to be considered, full proposals must be received at the Foundation offices no later than one month prior to the scheduled meeting of the Board.

An organization or institution submitting a request for funds to The Counselling Foundation of Canada must:

- Be a registered charitable organization;
- Have a permanent employee competent and available to implement the project; and
- Be willing to provide an accounting of the funds granted, signed by the financial officers of the institution/organization.

The order of priority for grants, according to geographic location is:

- 1. Toronto
- 2. Ontario
- 3. Canada

Submissions must include:

- Project budget with revenue sources an all expenditures detailed according to the calendar year(s) and/or portion of calendar year;
- Audited financial statements for last fiscal year and year-to-date financial statements;
- A list of the Board of Directors and relevant Advisory bodies; and
- Supporting references from community figures knowledgeable in the field.
